

NOVEMBER 27, 1963

Pursuant to a call by the Mayor the City Council of the City of Idaho Falls, met in Special Session in the Council Chambers of the City Building on the 27th day of November, 1963, at 8:00 o'clock P.M. for the purpose of conducting an official canvas of the ballots cast of November 26th, 1963, at the Second General Municipal Election. There were present at said Meeting: Mayor W. J. O'Bryant; Councilmen Foote, Leahy, and Creek. Also present: Roy C. Barnes, City Clerk; Fred Hahn of the City Attorney firm of Holden, Holden and Kidwell.

The Mayor announced that this was the time and the place for the official canvas of ballots cast at the Second General Municipal run-off election, held November 26th, 1963.
