

JUNE 27, 1957

Pursuant to a call by the Mayor, the City Council of the City of Idaho Falls, Idaho, met in a Special Session on Thursday, June 27, 1957, at 3:30 P.M. in the Mayor's Chambers for the purpose of studying and considering the new Gas Ordinance and any other business that might properly come up before the Council. Present: John B. Rogers, Mayor; Councilmen Petersen, Freeman, Foote. Absent: Councilman Johnson. Also present: Roy C. Barnes, City Clerk.

ORDINANCE NO.

AN ORDINANCE TO PROMOTE THE SAFETY AND WELFARE OF THE PEOPLE OF IDAHO FALLS, IDAHO, BY REGULATING THE DESIGN, INSTALLATION, MAINTENANCE, IMPROVEMENT, AND INSPECTION OF GAS INSTALLATIONS, OF GAS PIPING, AND OF GAS APPLIANCES IN BUILDINGS AND STRUCTURES; DEFINING THE TERMS THEREOF; ESTABLISHING MINIMUM REQUIREMENTS AND SAFETY STANDARDS FOR GAS INSTALLATIONS AND PIPING; REQUIRING WORK PERMITS AND SPECIFYING REGULATIONS THEREFORE, REQUIRING INSPECTION OF ALL WORK AND INSTALLATIONS; REQUIRING LICENSING OF ALL PERSONS INSTALLING OR WORKING ON GAS PIPING AND APPLIANCES; SETTING UP CLASSIFICATIONS AND REGULATIONS IN REGARD TO LICENSING; REQUIRING BONDING AND INSURANCE CERTIFICATES FOR LICENSEES; ESTABLISHING AN EXAMINING BOARD, PROVIDING FOR ITS DUTIES AND SETTING FORTH A CONSTITUTIONAL DECLARATION; REPEALING ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING WHEN THE ORDINANCE SHALL BECOME EFFECTIVE.

The above Ordinance was read by the City Clerk. It was moved by Councilman Petersen, seconded by Foote, that the above Ordinance be passed on two readings. Roll call as follows: Petersen, Aye; Foote, Aye; Freeman, Aye; No, None; carried.

It was moved by Councilman Foote, seconded by Petersen, that Claud Black, City Engineer be instructed to sign the street and grade plans as corrected pertaining to the Falls Valley Subdivision #1. Roll call as follows: Ayes, 3; No, None; carried.

The following application for a photographer's license was presented: De Bert Enterprises, 14149 Van Owen Street, Van Nuys, California. The applications indicated that this company desired to operate locally for a short time in the rear of the Mountain Electric Company, 961 Park Avenue, Idaho Falls. It was moved by Councilman Petersen, seconded by Foote, that this Meeting be recessed until July 8th, 1957. Carried.
