

SEPTEMBER 18, 1953

The City Council of the City of Idaho Falls, Idaho, met in Regular Session on September 18, 1953, at 8 P.M. in the Council Chambers at Idaho Falls, Idaho. Present: E. W. Fanning, Mayor; Councilmen Rogers, Petersen, Freeman and Foote. Also present: S. R. Rostad, City Clerk; T. R. Peters, Purchasing Agent; Arthur L. Smith, City Attorney; C. R. Black, City Engineer.

The minutes of a Meeting held on September 8th, were read and approved.

The following Bartender permits were presented, to-wit: H. W. Eames, Mint Bar; Howard H. Albert, Mint Bar and Paul D. Fisher, Russet Bar. It was moved by Councilman Freeman and seconded by Petersen, that the above permits be granted and proper cards issued. Roll call resulted as follows: Yes, 4; No, None; Carried.

A representative of the Salt Lake Tribune appeared before the Council, relative to placing an ad in the Empire Addition. The matter was referred to the Finance Committee for consideration.

The application for light and water assistance by Dorcas Clayton was presented. It was moved by Councilman Petersen and seconded by Rogers, that the application be denied. Roll call resulted as follows: Yes, 4; No, None; Carried.

(7) RESOLUTIONS

Seven Resolutions were presented authorizing the Mayor and City Clerk, to make, execute and deliver a deed to the following property owners, for property described as follows, pursuant to the provisions of Section 50-2951 Idaho Code.

WALDO C. WEST. Lots Forty-one (41) and Forty-two (42), Block Sixty-one (61) of Highland Park Addition to the City of Idaho Falls, Idaho.

PETE GENTHERS. Lots Twenty-nine (29) to Thirty-two (32), both inclusive in Block Sixty-four (64), Crows Addition to the City of Idaho Falls, Idaho.

NANCY BEAL. Lots Twenty-eight (28) and Twenty-nine (29), Block Twenty-seven (27) of Highland Park Addition to the City of Idaho Falls, Idaho.

J. FRANK HARRIS. Lots Ten (10) and Eleven (11), Block Ninety-seven (97) of Riverside Addition to the City of Idaho Falls, Idaho.

PERRY BROCKSOME. Lots Sixteen (16) to Eighteen (18), inclusive, Block Fifty-nine (59), Highland Park Addition to the City of Idaho Falls, Idaho.

BOYD EMERY. Lots Twenty-five (25) and Twenty-six (26), Block Fifty-five (55), Highland Park Addition to the City of Idaho Falls, Idaho.

It was moved by Councilman Petersen and seconded by Rogers, that the above Resolutions be approved and passed. Roll call resulted as follows: Yes, 4; No, None; Carried.

It was moved by Councilman Rogers and seconded by Petersen, that the City of Idaho Falls pay the sum of \$500.00 to Etta Hill, widow, for the following right-of-way, described as follows:

Beginning at a point on the south line of Cleveland Street, extended, that is east, 34.77 feet from the northeast corner of Block Twenty-four (24), Capitol Hill Addition to the City of Idaho Falls, Idaho, and running thence east, 330 feet; thence north 60 feet to the point of beginning.
