

MARCH 21, 1951

The City Council of Idaho Falls met in Special Session March 21, 1951 at 4:00 P.M. There were present: Mayor Sutton; Councilmen John B. Rogers, Vernon S. Johnson and Ross Corbett. Also present: Charles H. Williams, City Clerk

There was a proposed re-subdivision of the property belonging to Jack A. Pouch known as part of Blocks 81 and 82 of Highland Park Addition. After discussion the matter was tabled.

The matter of clearing a small interest charge which appeared on the books of the City Treasurer on bonds issued to pave the sidewalks on a portion of Block 73 and 74 of Highland and which paving had not been done due to other construction work was discussed and it was moved by Johnson and seconded by Rogers that \$153.01 be transferred from the General Fund to Local Improvement District #19. The principal amount of the bonds having been refunded by the contractor in November, 1950. Roll results in favor of the motion voting Aye, 3. Voting Nay, None. One Absent.
