The following Resolutions were read:

RESOLUTION

WHEREAS, the City of Idaho Falls, did, under and pursuant to the provisions of Chapter 25, Article 49, Idaho Code Annotated, and by deed of the City Treasurer of the City of Idaho Falls, Idaho, dated the 27th day of January, 1943, recorded in Book 44 of Deeds at Page 610, records of the County of Bonneville, State of Idaho, according to the recorded plat thereof; and

WHEREAS, E. A. WACKERLI has offered to pay to the City of Idaho Falls the amount for which the property was sold to the City, together with all installments of assessments subsequent to the one for which said property was sold and then due, together with penalties and interest thereon;
