

DECEMBER 18, 1942

Minutes of a Regular Meeting of the City Council of the City of Idaho Falls, Idaho, held December 18th, 1942.

There were present at said Meeting: E. W. Fanning, Mayor; Lee Walker, City Clerk; Councilmen Sutton, Crabtree, Wasley, Freeman. When the following proceedings were had to wit:

Minutes of the last Regular Meeting were read and approved.

The following applications for building permits were read:

No. 2992 Signed by John Walker

No. 2993 Signed by W. P. Gray

It was moved by Crabtree, seconded by Freeman, that the permits be approved. Roll call voting Aye: Wasley, Freeman, Sutton, Crabtree; Nay: None; motion carried.

Lease between Western Airlines, Inc. and the City, covering the main floor of the administration building at the airport was read. It was moved by Freeman, seconded by Crabtree, that the Mayor be authorized to sign the lease. Roll call voting Aye: Freeman, Sutton, Crabtree, Wasley; Nay: None; motion carried.

Application for widow's allowance on water and light account, signed by Mrs. Mary E. Kaler was read. It was moved by Sutton, seconded by Freeman, that the regular allowance be granted. Roll call voting Aye: Crabtree, Wasley, Freeman, Sutton; Nay: None; motion carried.

It was moved by Crabtree, seconded by Freeman, that the building inspector be authorized to get plans drawn up to rebuild the house which burned down at the lower power plant, and submit the plans at the next Meeting so that bids can be called for to rebuild the house. Roll call voting Aye: Sutton, Crabtree, Wasley, Freeman; Nay: None; motion carried.

The following Resolution was read:

RESOLUTION

WHEREAS, the City of Idaho Falls, did, under and pursuant to the provisions of Chapter 25, Article 49, Idaho Code Annotated, and by deed of the City Treasurer of the City of Idaho Falls, Idaho, dated the 27th day of January, 1942, recorded in Book 44 of Deeds, at Page 613, records of Bonneville County, Idaho, acquire title to and possession of all of Lots 19 and 20, Block 8, of Crow's Addition to the City of Idaho Falls, Bonneville County, Idaho, according to the recorded plat thereof; and,

WHEREAS, ANNA M. LAKE, has offered to pay to the City of Idaho Falls the amount for which the property was sold to the City, together with all installments of assessments subsequent to the one for which said property was sold and then due, together with penalties and interest thereon;

NOW, THEREFORE, BE IT RESOLVED:

That the Mayor and City Clerk be, and they are hereby authorized and directed, upon the payment of said sum of said purchaser, to make, execute and deliver to the said ANNA M. DECEMBER 18, 1942

LAKE for, and in the name of the City of Idaho Falls, Idaho, a deed to said property pursuant to the provisions of Section 49-2551 Idaho Code Annotated.

It was moved by Wasley, seconded by Crabtree, that the Resolution be adopted and approved. Roll call voting Aye: Wasley, Freeman, Sutton, Crabtree; Nay: None; motion carried.
