

MARCH 20, 1942

Minutes of a Regular Meeting of the City Council of the City of Idaho Falls, Idaho, held March 20th, 1942.

There were present at said Meeting: E. W. Fanning, Mayor; Lee Walker, City Clerk; Councilmen Sutton, Crabtree, Wasley; Absent: Freeman. When the following proceedings were had, to-wit:

Minutes of the last Regular Meeting were read and approved.

Application for Journeyman Plumbers license signed by Eldon M. Crooks was read. It was moved by Crabtree, seconded by Wasley, that the license be granted. Roll call voting Aye: Wasley, Sutton, Crabtree; Nay: None; Motion carried.

The following applications for building permits were read: No. 2911 signed by F. L. Pendleton and No. 2912 signed by Yellowstone Dairy Co. It was moved by Wasley, seconded by Crabtree, that the permits be approved. Roll call voting Aye, Sutton, Crabtree, Wasley; Nay: None; Motion carried.

An Ordinance entitled "AN ORDINANCE PROHIBITING THE ISSUANCE OF A TAXICAB LICENSE UNLESS THE OWNER SHALL HAVE FIRST FILED WITH THE CITY CLERK AN INSURANCE POLICY OR SURETY BOND PROTECTING THE PUBLIC AGAINST LOSS OR DAMAGE FROM THE OPERATION OF TAXICABS, AND MAKING IT UNLAWFUL TO OPERATE A TAXICAB WITHOUT HAVING ON FILE SUCH POLICY OF INSURANCE OR BOND AND PROVIDING THE PENALTIES FOR THE VIOLATION THEREOF, AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH", was read in full by the Clerk. It was moved by Crabtree, seconded by Wasley, that the Ordinance be passed on its third and final reading, and be adopted and approved. Roll call voting Aye: Crabtree, Wasley, Sutton; Nay: None; Motion carried. The Ordinance was then numbered 557 and passed to the Mayor for his approval, and was by him, the Mayor, duly signed and approved and ordered published in one issue of the Post Register, the official newspaper of the City of Idaho Falls.

Application for widow's allowance on water and light account, signed by Sophia Nelson, was read. It was moved by Wasley, seconded by Sutton, that the regular allowance be granted. Roll call voting Aye: Sutton, Crabtree, Wasley; Nay: None; Motion carried.

It was moved by Wasley, seconded by Sutton, that the Meeting adjourn. Roll call voting Aye: Wasley, Sutton, Crabtree; Nay: None; Motion carried.
