It was moved by Crabtree, seconded by Mehlhoff, that the above list of indigent widows be granted each month electricity in the net amount of \$5.00 and water in the net amount of \$2.00, and the widows are to turn over to the city their meter deposits which are to be credited on their accounts. Roll call. Voting aye: Wasley, Evans, Sutton, Crabtree, Brandl, Fanning, Gourley, Mehlhoff. Voting nay: None. Motion carried.

After considering all bids received for garbage removal which were received and opened June 16th, 1939, it was moved by Fanning, seconded by Brandl, that the contract for Garbage Removal be let to Ray Messenger, the low bidder for one year at \$8,000.00 and he is to furnish a \$1,000.00 bond, and also a thirty day cancellation clause must be inserted in the contract agreement. Roll call. Voting aye: Evans, Crabtree, Brandl, Fanning, Wasley. Voting nay: Sutton, Gourley, Mehlhoff. Motion carried.

It was moved by Brandl, seconded by Fanning, that the meeting adjourn. Roll call. Voting aye: Sutton, Crabtree, Brandl, Fanning, Gourley, Mehlhoff, Wasley, Evans. Voting nay: None. Motion carried.
