The following claims were read which were not approved by the Finance Committee: J. T. Evans, 76.20; Joe Mauro, 180.00; Domenico DeLuco, 185.00. It was moved by Gourley, seconded by Wright, that the claims be rejected. Roll call voting Aye: Mehlhoff, Gourley, Crowley, Wright, Evans; Motion carried.

Building permit No. 1049 signed by M. Nojima was read. The Mayor referred same to the Building Committee.

Building permit No. 1048 signed by William M. Clark was read. It was moved by Crowley, seconded by Mehlhoff, that the permit be granted. Roll call voting Aye: Gourley, Crowley, Wright, Evans, Mehlhoff; Motion carried.

It was moved by Evans, seconded by Crowley, that the Meeting adjourn. Roll call voting Aye: Crowley, Wright, Evans, Mehlhoff, Gourley; Motion carried.
