

**ADVERTISEMENT FOR BIDS

Separate sealed BIDS for the above named project, will be received by the City of Idaho Falls at the office of the City Clerk at 308 Constitution Way, Idaho Falls, Idaho 83402, until **2:00 PM, LOCAL TIME, TUESDAY, JUNE 2ND, 2020**, and then publicly opened and read aloud. Remote access to view the opening will be provided to plan holders prior to the opening.

This project shall consist of the Contractor furnishing all tools, labor, equipment and materials necessary to install thermoplastic pavement markings in various locations throughout the City, and any additional items specifically defined in the Bid Documents.

Documents may also be examined at the office of the Public Works Department at 380 Constitution Way, Idaho Falls, Idaho 83402 and purchased at the same office for a fee of \$25.00 per individual set.

A Pre-Bid Meeting of the proposed project will be conducted at **2:00 PM, LOCAL TIME, TUESDAY, MAY 26TH, 2020**. The meeting will be held remotely via Zoom. Details for login are included in Article 5 of Document 00200 – Instructions to Bidders.

In determining the lowest responsive bid, the Owner will consider all acceptable bids on a basis consistent with the bid package. The Owner will also consider whether the bidder is a responsible bidder.

Before a contract will be awarded for work contemplated herein, the Owner will conduct such investigation as is necessary to determine the performance record and ability of the apparent low Bidder to perform the size and type of work specified under this Contract. Upon request, the bidder shall submit such information as deemed necessary by the Owner to evaluate the Bidder's qualifications.

All bids must be signed and accompanied by evidence of authority to sign.

Bids must be accompanied by Bid Security in the form of a bid bond, certified check, cashier's check or cash in the amount of 5% of the amount of the bid proposal. Said bid security shall be forfeited to the City of Idaho Falls as liquidated damages should the successful bidder fail to enter into contract in accordance with their proposal as specified in the Instructions to Bidders.

The City of Idaho Falls reserves the right to reject any or all proposals, waive any nonmaterial irregularities in the bids received, and to accept the proposal deemed most advantageous to the best interest of the City of Idaho Falls.
