CALLS FOR SERVICE/INCIDENTS

Notable CFS/Incidents

- 1/18/21 2021-1900 Vehicle Accident with Injuries
Shortly before 4:00 a.m., a driver fell asleep at the wheel and crashed their vehicle into a power pole on Sunnyside Road. The driver sustained a possible broken leg and was transported to an area hospital via Idaho Falls Fire Ambulance. Idaho Falls Power and Rocky Mountain Power responded to address the power line safely.
- 1/19/21 2021-2201 Psychiatric Issue
Officers responded to the area of Alturas Academy for a report of a woman yelling that someone had kidnapped her daughter. Officers found that the woman (who did not have a child attending the school) was having a psychiatric issue.
- 1/22/21 2021-2460 Assist Other Agency – Idaho Falls Fire Department
Officers responded to a residence for a report of an oven fire where three juveniles were home alone. The oldest teenage sibling called 911 and evacuated their younger siblings and pets. Officers responded ahead of fire, met the juveniles outside, and entered the residence to find that the fire had self-extinguished. Idaho Falls Fire also responded and ensured that all was safe.
- 1/23/21 2021-2681 Weapons
Officers reported to a residence for a report of an accidental gunshot. An intoxicated individual was handling a firearm and believed it was unloaded. The firearm was loaded and the person accidentally discharged a round, causing a non-life-threatening injury to themselves. The person was transported to an area hospital for treatment.
