## CALLS FOR SERVICE/INCIDENTS

### *Notable CFS/Incidents*

- 5/9/21            2021-16956  
At approximately 2:30 a.m., Officers responded to the area of 645 Broadway for a report of a vehicle abandoned in the roadway. Officers arrived and found a man standing in the middle of the roadway sweating profusely, spinning in circles, and speaking incoherently. Officers detained him for his safety and arranged for a tow company to come tow the man's vehicle. The man later admitted to officers that he had used methamphetamine, causing the abnormal behavior. The man was arrested for Misdemeanor Under the Influence of a Controlled Substance in Public.
- 5/9/21            2021-17025            Hit & Run  
Shortly after 9:00 p.m., Officers responded to a report of a vehicle collision where one of the vehicles fled the scene. A witness to the collision and was able to keep the vehicle in sight as it fled from the scene and relayed information about the vehicle and the driver to dispatch while Officers were en route. Thanks to the assistance of this witness, officers were able to quickly apprehend the suspect driver. The driver was arrested for DUI and Leaving the Scene of a Vehicle Accident.
- 5/10/21          2021-17099            Suspicious  
Shortly before 4:00 p.m., Officers responded to the Idaho Falls Library for a report of a man with a knife. Officers responded and located a man matching the description given by the reporting person. Officers spoke to the man who was cooperative with officers and stated that he was in possession of two pocket knives. The man told officers he had briefly pulled one knife out to use it to open a food item he had with him. No one reported that the man had threatened anyone or otherwise brandished the knives, and Officers determined that no crime had occurred.
- 5/10/21          2021-17121            Misdemeanor Battery  
Shortly before 8:00 p.m., Idaho Falls Police Officers responded to a residence in the area of Gladstone Street and Lee Avenue for a report of a Domestic Disturbance. Officers arrived and could hear yelling inside and decided to enter the residence out of concern for the people inside. Officers pushed the door open and immediately saw a man on top of a woman pinning her in a chair. Officers entered the residence and pulled the man off the woman and placed him in handcuffs. The woman was found to have numerous cuts, scrapes and bruises around her face arms and neck and told Officers that the man had hit her several times and put his hands around her neck. The woman told officers that the man was an acquaintance and that she was letting him stay at her residence for the night because he is homeless.

The man, identified as Kirk Huff, admitted to hitting the woman and was also found in possession of a small amount of marijuana.

Kirk Huff, a 58-year-old man, was arrested for Battery and Misdemeanor Possession of a Controlled Substance.

- 5/11/21 2021-17209 Road Rage Incident Involving a Firearm  
At approximately 3:20 p.m., Officers responded to the area of 1700 Woodruff for a report of a road rage incident involving a firearm. The caller reported that he had confronted a man for speeding in a parking lot when the man pulled a gun on the person before fleeing the area. The caller provided a vehicle description and a license plate number which officers used to identify the other involved party. Officers contacted the driver who agreed that the caller had yelled at him for speeding in the parking lot and to having a handgun holstered on his hip, but denied brandishing it or threatening the caller at any time and reported that the caller had been reaching into the vehicle and aggressing him. There were no other witnesses to the incident and it remains under investigation.
- 5/13/21 2021-17539 Indecent Exposure  
At approximately 7:00 p.m., Officers responded to the Rose Hill Cemetery on Rollandet Ave for a report of a naked man in a public area. Two juvenile females reported to Officers that they had seen a naked man jumping into the canal and on top of grave stones. Officers located the man, who was only wearing underwear when Officers found him. The man admitted to being under the influence of methamphetamine and mushrooms and was arrested for Under the Influence of a Controlled Substance in Public and cited for Indecent Exposure.
- 5/13/21 2021-17545 Disturbing the Peace  
At approximately 8:00 p.m., Officers responded to the area of 3100 S Yellowstone Hwy for a report that a drunk woman had reportedly threatened a child. Officers spoke with witness and involved parties and found that a child had been playing in a communal area when the woman's cat had approached the child. The woman, who appeared to be significantly inebriated while speaking with officers, then approached the child and told the child to leave the cat alone using expletives and threatening language. The woman denied threatening the child but admitted to swearing at the child about the cat. The woman was cited for Disturbing the Peace and advised to speak to a parent if she had concerns about a child in the future.
